Brief Description of Proposed Action (include purpose or need): Norbut Solar Farms proposes to construct a 15 MWac solar facility consisting of three nominally distinct but contiguous sites. The proposal also includes subdivision and a lot combination. The site currently consists of agricultural fields and wooded areas. Improvements include an impervious gravel road, perimeter fencing, stormwater management features, and the solar panels with supporting electrical equipment. Wooded areas will be cleared as necessary for construction of the solar field areas, construction of the access drive and the utility connections. All areas within the site will be seeded utilizing a vegetative mixture intended for use with the solar farm projects. PV panels will be mounted on racking systems and the solar facility will be connected to the electrical grid. The Project will deliver clean, emission-free renewable energy to the adjacent high voltage electrical grid.
